Objective and investment policy

The fund aims to provide a combination of capital growth and income that is higher than the Deutsche Numis Smaller Companies Index (excluding Investment Companies), net of the Ongoing Charge Figure, over any five-year period.

Core investment: At least 80% of the fund is invested in the shares of smaller companies, across any sector, that are listed in the UK. These companies are at the initial time of purchase:

- in the bottom 10% (by market capitalisation) of the FTSE All-Share Index; or
- in the Deutsche Numis Smaller Companies Index (excluding Investment Companies); or
- listed on the Alternative Investment Market.

Other investments: The fund may invest in other funds and cash or assets that can be turned into cash quickly.

Derivatives usage: To reduce risk and costs.

Strategy in brief: The fund manager selects stocks using a bottom-up approach. A long-term perspective is adopted with particular focus placed on the factors driving a company's growth, its competitive advantage, change, quality of management and valuation.

Benchmark: Deutsche Numis Smaller Companies Index (excluding Investment Companies)

The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used to measure the fund's performance and, together with the other index, and the Alternative Investment Market as referenced in "Core investment" constrains the fund's portfolio construction as they define the investment universe of the fund.

The fund is actively managed. Within the given constraints, the fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

For performance measurement purposes the benchmark is shown or hedged into the relevant share class currency.

Other information

You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund will be rolled up into the value of your investment.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The charges shown in the table are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

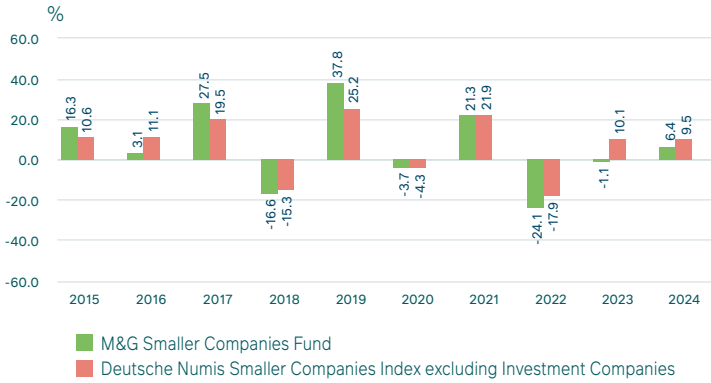

The ongoing charge is based on expenses for the period/year ending 30 June 2024. This figure may change from year to year. It excludes portfolio transaction costs. The fund's annual report for each financial year will include details on the exact charges made.
