Objective and investment policy

The fund aims to:

- Provide a higher total return (capital growth plus income), net of the Ongoing Charge Figure, than that of the FTSE All-Share Index over any five-year period, and
- As its Sustainability Goal, support the mitigation of climate change by investing at least 70% of the Fund in companies that contribute towards the Paris Agreement climate change goal and have the potential to reduce their contribution to climate change determined by their potential to decarbonise their operations over time and ultimately reach Net Zero.

Core investment: At least 80% of the fund is invested directly in the shares of companies, across any sector and of any size, that are based, or do most of their business, in the UK. The fund is concentrated and usually holds shares in fewer than 50 companies.

Other investments: The fund may invest in other funds (including funds managed by M&G) and cash or assets that can be turned into cash quickly.

Derivatives usage: To reduce risk and costs.

Strategy in brief: The Fund is a focused UK equity fund, investing long term in companies which contribute to the Paris Agreement climate change goal, and demonstrate profitability using a bottom-up stock picking approach, driven by the fundamental analysis.

At least 70% of the fund's assets will be "Improvers" which contribute to the fund's Sustainability Goal. The remaining assets of the fund will be companies that have already reached Net Zero, companies with low carbon intensity, companies that provide climate solutions held for diversification and assets held for liquidity purposes.

Sustainability considerations are fundamental in determining the fund's investment universe and assessing business models, as further described in the Consumer Facing Disclosure which can be found here.

Benchmark: FTSE All-Share Index

The benchmark is the target for the fund's financial objective and is used to measure the fund's financial performance. The index has been chosen as the fund's benchmark as it best reflects the financial aspects of the fund's investment policy.

The fund is actively managed so the fund manager has complete freedom in choosing which investments to buy, hold and sell. The fund's holdings may deviate significantly from the benchmark's constituents, and therefore, so may performance.


You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund may be paid out to you semi-annually.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The fund's annual report for each financial year will include details on the exact charges made.

For Income shares, the ongoing charge is taken from investments held in the fund's portfolio and not from the income these investments produce. The deduction of this charge will reduce the potential growth of your investment.
