### Objective and investment policy

The fund aims to provide a higher total return (the combination of capital growth and income), net of the Ongoing Charges Figure, than that of the MSCI India Index over any five-year period.

**Core investment:** At least 80% of the fund is invested in the equity securities and equity related instruments of companies that are incorporated, listed, domiciled or do most of their business in India.

**Other investments:** Other funds (including funds managed by M&G) and cash or assets that can be turned into cash quickly.

**Derivatives Usage:** To reduce risks and costs.

**Strategy in brief:** The fund manager uses a fundamental, bottom-up approach to identify stocks that are likely to outperform based on their financial and market characteristics. The fund manager performs fundamental analysis on companies assessing their potential in light of their financial, economic, political, and regulatory conditions to identify opportunities arising from significant deviation between the price and the estimated value of the stock.

The strategy focuses in particular on those stocks where the fund manager believes it has a strong insight, and uses independent, proprietary research to identify opportunities from the investment universe of securities and concentrates its research on these companies. Stock selection is expected to be the main driver of performance.

**Benchmark:** MSCI India Index

The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the Fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed. The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

For performance measurement purposes the benchmark is shown or hedged into the relevant share class currency.

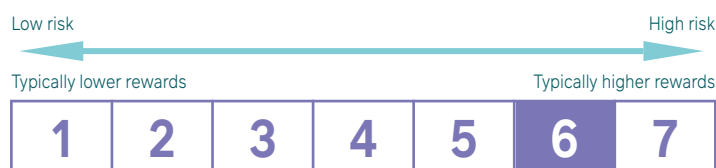
You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund may be paid out to you annually.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

For Income shares, the ongoing charge is taken from investments held in the fund's portfolio and not from the income these investments produce. The deduction of this charge will reduce the potential growth of your investment.
