You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type:

The Fund is a sub-fund of M&G (Lux) Investment Funds 1, a Société d'Investissement à Capital Variable (SICAV), organised as an umbrella fund with segregated liability between sub-funds, governed and established under Luxembourg Law as an Undertaking for Collective Investment in Transferable Securities (UCITS).

Objective:

The Fund aims to:

- financial objective: provide capital growth plus income to deliver a higher return than the sustainable global bond market over any five-year period, and.
- sustainable objective: contribute to a sustainable economy by investing in global bonds supporting environmental and/or social goals.

Core investment: at least 80% of the Fund is invested in higher quality bonds issued by companies from anywhere in the world including emerging markets. The Fund may invest in Chinese bonds denominated in renminbi. The Fund typically invests in assets denominated in euro or in other currencies hedged back to euro. The Fund invests in securities that meet the ESG Criteria, applying an Exclusionary Approach, in addition to its sustainable investment strategy used in pursuit of the sustainable investment objective, as described in the precontractual annex.

Other investments: the Fund may invest up to a combined maximum of 20% in lower quality corporate bonds, government bonds and public securities, asset-backed securities, contingent convertible debt securities (capped at 10%), cash (meaning eligible deposits) and assets that can be turned quickly into cash. Additionally, the Fund may invest in other funds.

Derivatives usage: for investment purposes and to reduce risk and cost.

Strategy in brief:

- Investment approach: the Fund invests over the long term in bonds of companies that seek to deliver solutions to some of the world's major social and/or environmental challenges and in bonds issued specifically to finance environmental or social projects. To be eligible for investment, the investment manager only selects bonds that positively contribute to at least one of six solution areas as explained in the precontractual annex. The Fund is globally diversified by investing in a range of issuers, sectors and geographies. The investment manager seeks to take advantage of fundamental and relative value opportunities. Investment returns will primarily be driven by individual credit selection. An in-house team of credit analysts assists the investment manager in individual credit selection along with the monitoring of issuers held by the Fund.
- Investment manager's ESG classification: Planet+ / Sustainable, as defined in the Prospectus.

Benchmark: Bloomberg Global Corporate Green Social Sustainability Bond Index (EUR-hedged)

The benchmark is a comparator against which the Fund's performance can be measured. The index has been chosen as it best reflects the scope of the Fund's financial objective. The Fund is actively managed and within given constraints. The investment manager has complete freedom in choosing which investments to buy, hold and sell in the Fund. The Fund's holdings may deviate significantly from the benchmark's constituents, and as a result the Fund's performance may deviate materially from the benchmark. For performance measurement purposes the benchmark may be denominated or hedged into the relevant share class currency. The benchmark for each share class will be shown on the M&G website.

Intended retail investor:

The Fund is designed for retail and institutional investors who want a combination of capital growth and income from a portfolio of global bonds that support environmental and/or social goals, and who have sustainability preferences. The return on your Fund is directly related to the value of its underlying assets, which is determined by the credit rating and the markets' view of the debt issuer, as well as reflecting broader economic and political themes. As an investor your capital is at risk. The value of your portfolio, and any income you may receive from it, can go down as well as up. You may get back less than you originally invested.

Any income from the Fund will be rolled up into the value of your investment.

Term: The Fund has no set maturity date but is designed to be held for a minimum of 5 years. However, it is possible for the Directors of the company to terminate the Fund, without the prior consent of the shareholders, where it is deemed to be uneconomic to run or in the best interests of shareholders. Refer to the Prospectus for more information.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product may lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the value of your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The risk indicator assumes you keep the product for 5 year(s). This product has no maturity date.

Performance scenarios

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products.

The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment/product.

The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you.

The figures do not take into account your personal tax situation, which may also affect how much you get back. What you will get from this product depends on future market performance. What happens if M&G Luxembourg S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by the Depositary detailed in the prospectus. In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). The Fund is not covered by an investor compensation scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed, in the first year you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the fund performs as shown in the moderate scenario. The figures assume \$ 10.000,00 is invested.

(*) This illustrates how costs reduce your return each year over the holding period. How long should I hold the investment and can I take money out early?

Recommended holding period of this Fund is 5 years. The recommended holding period was selected in accordance with the Fund's objective. You may redeem your shares/units on any dealing day. The redemption price is calculated by reference to the Net Asset Value per share/unit of the relevant share/unit class as at the Valuation Point on the relevant dealing day. If you cash in before the end of the recommended holding period, this will increase the risk of lower investment returns or a loss.
