Objective and investment policy

The fund aims to provide:

- a combination of capital growth and income, net of the Ongoing Charge Figure, that is higher than that of the S&P 500 Index over any five-year period; and
- an income distribution that increases every year in US dollar terms.

Core investment: At least 80% of the fund is invested directly in the shares of companies, across any sector and of any size, that are based, or do most of their business, in the US and Canada. The fund is concentrated and usually holds shares in fewer than 50 companies.

Other investments: The fund may invest in the shares of non-US and non-Canadian companies, other funds (including funds managed by M&G) and cash or assets that can be turned into cash quickly.

Derivatives usage: To reduce risk and costs.

Strategy in brief: The fund manager focuses on companies with the potential to grow their dividends over the long term and selects stocks with different sources of dividend growth to build a fund that has the potential to cope in a variety of market conditions. The fund invests with a long-term view of typically at least five years. When attempting to grow distributions, the fund manager's main focus is on delivering an increase in US dollar terms.

Benchmark: S&P 500 Index
The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction. The fund is actively managed. The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents. For performance measurement purposes the benchmark is shown or hedged into the relevant share class currency.

Other information

You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund will be rolled up into the value of your investment.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The main risks that could affect performance are set out below:

 - In exceptional circumstances where assets cannot be fairly valued, or have to be sold at a large discount to raise cash, we may temporarily suspend the fund in the best interest of all investors.

The charges shown in the table are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

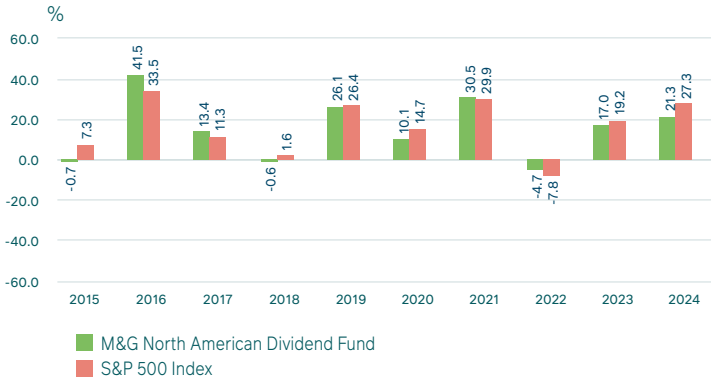

The ongoing charge is based on expenses for the period/year ending 30 August 2024. This figure may change from year to year. It excludes portfolio transaction costs. The charges are mostly, if not exclusively, the Annual Charge which may be discounted depending on the size of the fund. The Annual Charge without any discount is 0.55%. The fund's annual report for each financial year will include details on the exact charges made.
