This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type:

The Fund is a sub-fund of M&G (Lux) Investment Funds 1, a Société d'Investissement à Capital Variable (SICAV), organised as an umbrella fund with segregated liability between sub-funds, governed and established under Luxembourg Law as an Undertaking for Collective Investment in Transferable Securities (UCITS).

Objective:

The Fund aims to provide a combination of capital growth and income over the term of the Fund, while applying ESG Criteria.

Core investment: during the Investment Period, as defined in the Fund's Prospectus, at least 65% of the Fund is invested in high quality bonds issued or guaranteed by governments and public issuers, and companies from anywhere in the world, including emerging markets. These bonds can be denominated in any currency. Currency exposures are typically in EUR or hedged back to EUR. In the period leading up to maturity, the Fund may hold higher levels of cash and assets that can be turned quickly into cash to fund the return of capital to investors. The Fund invests in securities that meet the ESG Criteria, applying an Exclusionary Approach as described in the precontractual annex.

Other investments: the Fund may invest up to 35% in lower quality and unrated bonds, up to 10% in asset-backed securities, and up to 10% in contingent convertible debt securities. The Fund may also invest in other funds and up to 35% in cash (meaning eligible deposits) and assets that can be turned quickly into cash.

Derivatives usage: for investment purposes and to reduce risk and cost.

Strategy in brief:

• Investment approach: the Fund predominantly adopts a buy and maintain strategy, whereby the majority of the bonds held within the Fund are expected to be held until maturity. The investment process combines a bottom-up value focused approach and "top-down" macroeconomic, asset, sector and geographic considerations. The investment strategy aims to earn an attractive yield whilst balancing credit risk and diversification. The Fund is diversified by investing in a range of individual issuers, sectors and geographies. The investment manager is assisted in the selection of individual bonds and monitoring of issuers by an in-house team of analysts.

• Investment manager's ESG classification: Planet+ / ESG Enhanced, as defined in the Fund's Prospectus.

Benchmark: the Fund is actively managed and it has no benchmark. Investors can assess the performance of the Fund by its objective to provide a combination of capital growth and income over the term of the Fund.

Intended retail investor:

The Fund is designed for retail and institutional investors who want a combination of capital growth and income from a portfolio composed mainly of debt instruments from anywhere in the world, and who have sustainability preferences. The return on your Fund is directly related to the value of its underlying assets, which is determined by the credit rating and the markets' view of the debt issuer, as well as reflecting broader economic and political themes. As an investor your capital is at risk. The value of your portfolio, and any income you may receive from it, can go down as well as up. You may get back less than you originally invested.

Any income from the Fund will be rolled up into the value of your investment.

Term: The Fund has a fixed term of four (4) years from the First Day of the Investment Period as defined in the Fund's Prospectus.

• Subscriptions can be made during the Initial Offer Period determined by the Manager prior to the launch of the Fund. If such subscriptions are insufficient to invest the Fund in accordance with its investment policy, the Manager may decide (1) not to proceed with the launch; or (2) to launch and accept subscriptions during a Pre-Investment Period ("PIP") of up to three (3) months. The PIP is optional, at the discretion of the Manager. The Fund will only hold cash and near cash during the PIP.

• If at the end of the PIP subscriptions are still insufficient, the Manager may decide to liquidate the Fund, in which case 80% of the Single Charge will be returned to the shareholders.

• No subscription is permitted during the Investment Period, unless otherwise decided by the Manager, at its discretion.

• The Fund will be liquidated on the maturity date and shares in the Fund will be compulsorily redeemed at the prevailing Net Asset Value per share.

• Investors who remain invested until maturity will not be subject to any redemption charge, but investors who redeem prior to maturity will be subject to a redemption charge as set out in the Fund's Prospectus.

• The maturity date may be deferred or brought forward by up to three months, or any other period, if the directors believe that it is in the interest of shareholders. Shareholders will be notified of such decision and will be given the possibility to redeem their shares free of charge.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product may lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the value of your investment.

You may have to pay significant extra costs to cash in early.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The risk indicator assumes you keep the product for 4 year(s) from the First Day of the Investment Period. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Performance scenarios

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products.

The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment/product.

The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back. What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the fund over the last 10 years. Where fund data is not available, the benchmark or another suitable proxy is used. Markets could develop very differently in the future.

What happens if M&G Luxembourg S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by the Depositary detailed in the prospectus. In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). The Fund is not covered by an investor compensation scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed, in the first year you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the fund performs as shown in the moderate scenario. The figures assume € 10.000,00 is invested.

(*) This illustrates how costs reduce your return each year over the holding period. These figures include the maximum distribution fee that the person selling you the product may charge. This person will inform you of the actual distribution fee.

How long should I hold the investment and can I take money out early?

Recommended holding period of this Fund is 4 years from the First Day of the Investment Period. The recommended holding period was selected in accordance with the Fund's objective and equals the Fund's fixed term. Investors who redeem prior to maturity will be subject to a redemption charge as set out in the Fund's Prospectus. You may redeem your shares on any dealing day. The redemption price is calculated by reference to the Net Asset Value per share of the relevant share class as at the Valuation Point on the relevant dealing day.
